The Highway Department finished the springtime sweeping of town roads and is continuing ditch work along Mcneil road and portions of Near road. We have replaced culvert pipes on Mill Hill and Decker roads.

The rabies clinic was held on May 7<sup>th</sup> in the new addition at the Highway garage with 73 animals attending.

The town clean-up day is scheduled for Saturday Oct 29<sup>th</sup>.

The 284 agreement that is before the board represents our CHIPS allocation and monies from our budgeted road maintenance line (DA5110.4). The Pave/NY Bridge/NY portion of our CHIPS funding and what it takes to qualify for this money, has not cleared the state senate yet. That amount should be \$23,311.66. Any increase in the road maintenance line could be added.

The Highway Crew has finished up the road side mowing for the year and has started removing dead trees along our roads.

Under Shared Services we had 2 trucks in the Town of Taghkanic for 2 days.

The 95 Case Backhoe is in need of torque converter and transmission repair with an estimated cost of \$8000. The retail value of this machine is approximately \$14,000 in good working order. I do not recommend repairing this 21 year old Backhoe.

I do recommend the purchase of a 2017 John Deere 310SL Backhoe from Nortrax of Clifton Park. John Deere Backhoes are under the NJPA purchasing program. The cost of this unit is \$106,854 and has an 8 week delivery time.
