COUNCILMAN MORTENSON EXPRESSED HIS CONCERN THAT THE LAW EXCEEDS THE NEEDS OF A RURAL COMMUNITY.

COUNCILMAN PATERSON STATED THAT HE AGREED WITH THE INTENT BUT HE WAS CONCERNED THE LAW WAS VAGUE AND OVER REACHING.

MR. REPLANSKY STATED THAT THE CODE ENFORCEMENT OFFICER MAKES A RECOMMENDATION TO THE TOWN BOARD, IT IS THE DECISION OF THE BOARD TO ACT. THIS APPLIES IN ONLY THE MOST EGREGIOUS CASES.
