### **PUBLIC COMMENT ON OLD BUSINESS**

Mr. Steve Bogdanffy requested a letter from the Town permitting delivery trucks that are over 5 tons to travel over the town roads to deliver to Feather Ridge Farm. Supervisor Reilly told Mr. Bogdanffy that any weight limit imposed by the town does not apply to local deliveries.

The County cell tower at Route 82 transfer station is under construction. Supervisor Reilly will see what providers will be located on the tower.

Items for the 2024 Zoning Law

- The distance that signs need to be located off the roadway for mowing and maintenance. The suggested distance is 5-6 ft.  
Political signs must be within 30 days of the election.  
All temporary signs must be removed 7 days after the event.
- Discussion of storage garages on parcels that have no principal dwelling.
