The 2016 A1110.1 salary line for the Justice Court is: \$16, 792- Justice (2) \$16,146-Clerk \$1,000-Stipend \$2,500 Assistant

Councilman Mortenson spoke to Special Council David Dellehunt for clarification of the clerk position.

The Town Board could not remove a clerk- This was not the intention of the board- an additional clerk was added at the request of Judge Denenberg. The Town Board can set salary.

The board will honor Judge Denenberg's request for a court clerk, court clerk Dora Schultz will remain clerk for both justices. Jay Gieseler will clerk for Judge Denenburg, until such time as Judge Schultz gives his recommendation.
