- I. SUPERVISOR GARRICK CALLED THE MEETING TO ORDER AT 5:00 PM.
- II. SUPERVISOR GARRICK, COUNCILMAN REILLY, COUNCILMAN GALM, COUNCILMAN COONS AND COUNCILMAN PATERSON WERE ALL PRESENT.
- III. SALUTE TO THE FLAG.

DISCUSSION WITH CHURCH RD. RESIDENTS

- SUPERVISOR GARRICK OPENED THE DISCUSSION WITH THE CHURCH RD RESIDENTS. HE EXPLAINED THAT CHURCH RD, A GALLATIN TOWN RD. IS A USER ROAD. THE ROAD IS ONE OF THE LAST DIRT ROADS MAINTAINED BY THE TOWN.
- HIGHWAY SUPERINTENDANT BILL COONS STATED THAT HE IS CONCERNED ABOUT THE SAFETY OF THE ROAD. THE NEEDED ROAD IMPROVEMENT IS A MULTI STEP PROCESS. FIRST DITCHES, CULVERTS AND DRAINAGE ARE IMPROVED, NEXT THE ROAD BED BASE IS GRAVELED AND FINALLY THE ROAD IS OIL AND STONED.
- THE RESIDENTS PRESENT THEN VOICED THEIR QUESTIONS AND CONCERNS.
 - THE COSTS OF MAINTENANCE OF CHURCH RD WAS QUESTIONED
 - O WHETHER THE RESIDENTS WILL BE COMPENSATED IF ANY OF THEIR LAND IS TAKEN TO WIDEN THE ROAD
 - WHY THE ROAD NEEDS TO BE WIDENED ON THE CURVE FOR SAFETY OF THE SNOW PLOW, WHEN IT HAS BEEN PLOWED FOR MANY YEARS WITHOUT INCIDENT.
 - THE BOARD WAS THANKED FOR OPENING UP THE DIALOG WITH THE RESIDENTS BUT MOST OF THE CHURCH RD RESIDENTS WANT TO MAINTAIN THE RURAL CHARACTER OF THE ROAD.
 - IN A SEVERE WINTER THE SNOW ON THE ROAD SIDES WOULD NARROW THE ROAD SO THAT EMERGENCY VEHICLES WOULD NOT BE ABLE TO PASS EACH OTHER.
 - o ROAD IMPROVEMENTS WOULD INCREASE VEHICLE SPEED
 - o RURAL CHARACTER WAS IN THE COMPREHENSIVE PLAN
 - THERE IS NO CENSUSES FROM THE RESIDENTS ON EXACTLY WHAT THEY WANT FOR THE ROAD

COUNCILMAN REILLY WAS CONCERNED IF THERE WAS A LAWSUIT IT WOULD BE A LIABILITY TO THE TOWN TO HAVE JUST ONE UNPAVED ROAD.

SUPERVISOR GARRICK STATED THAT ONE OPTION COULD BE TURNING THE ROAD BACK TO THE RESIDENTS. HE THANKED THE RESIDENTS FOR THEIR QUESTIONS AND CONCERNS AND WOULD KEEP THE DIALOG OPEN ON THE MAINTENANCE ISSUES OF CHURCH RD.
